Interaction Licence

Nature Conservation Legislative Requirements and Conditions

Legislative Requirements

- ILLR01 The holder of an interaction licence must keep a record of all activities carried out under the licence. The records must include all matters outlined in section 8 of the approved Interaction Plan and must be made at the end of each day/night.
The records must be made available for inspection by a conservation officer if asked.

Condition

- AACC01 ADVISORY INFORMATION NOTICE
(S) If a relevant person for the holder is to carry out an activity under this authority, this person must be in possession of a copy of the authority that is:
(a) for a corporation: signed by the person in charge; or for an individual: signed by the authority holder; and
(b) include the person's full name and residential address; and
(c) show any instructions the authority holder has given (for example, limits on species, numbers, or the activity location).
- CWM01 All activities are to be carried out in accordance with the approved Interaction Plan contained in and attached to Fretwood Pty Ltd Interaction Plan and email titled "Required Information for Interaction Licence submitted to the department on 3 July 2026 and 24 July 2026
- CWM03 The permit holder must deliver any animal suffering from an injury or illness to a veterinarian or licenced wildlife carer within 72 hours for assessment and rehabilitation.
- CWM05 The record must include information about the activities carried out under the licence and identify problems or concerns relating to animals or clients involved in the activities, for example:
1. any increase in illness or injury in the animals,
2. any incidence of aggression by animals against holder's clients participating in the activities,
3. any complaint by a member of the public about the impacts of the activity and how these problems or concerns were identified and resolved.
